# Disclaimer and regulations

## Disclaimer

I willingly and at my own risk participate in the Big Rig Truck Drag Racing. In signing this release, I declare to be aware of the risks entailed by an activity like this. I agree that the Big Rig committee will in no event be liable for any accident on site.

## Regulations 2018

01. Big Rig Truck Drag Racing Committee assumes no responsibility for accidents and/or mechanical failure.
02. Participants are fully responsible for their vehicle in case of damage (ex. collision, mechanical breakdown, etc.). The Big Rig Truck Drag Racing Committee will not be held responsible.
03. The driver is responsible for his passengers as well as team members, family and any other accompanying persons in the paddock and within fenced-in areas.
04. Registration for the event: \$35 per class per truck.
05. All participants must be present at the participants meeting. An attendance sheet will be signed at the meeting. If there is an attendance absence, there will be a loss of points for the FECCLQ members.
06. All participants must remain between the dotted track racing lines while racing.
07. The races will be double elimination.
08. **A FALSE START = ACCEPTED - A SECOND FALSE START = DEFEAT**
09. When a competitor is called initially, he/she should be present within the following 5 minutes or else, **A DEFEAT**.
10. No speeding will be tolerated off of race tracks.
11. Any act or word or note unsportsmanlike or aggressive towards volunteers responsible for the race tracks will not be tolerated (disqualification).
12. No alcoholic beverages will be tolerated for drivers and their passengers during the race competitions (instant disqualification). In doubt, a breathalyzer test will be required.
13. In class B, A and Open, a protective plate or other **MUST** be installed on each side of the truck to protect tanks and spectators in the event of mechanical failure. (ex. clutch, seal, driving-shaft, etc..).
14. No additional injection. A mechanic and inspector will check this with complete impartiality.
15. **All registered participants are entitled to one single test. Even if there is a "red light" at the start of the test, the participant must continue and take off. THERE WILL BE NO RETURNS. The test in classes A and B provides for the Open class. Class C = Truck stock.**

**THE ALLOTTED TIME FOR TRUCK REPAIRS IS 30 MINUTES PER DAY. THIS DELAY BEGINS WHEN A PARTICIPANT BEGINS HIS/HER RACE. THE PARTICIPANT MAY CONSERVE HIS/HER 30-MINUTE ALLOTTED TIME BY FORFEITING THE RACE, HOWEVER IT IS NOT ACCUMULATIVE OR TRANSFERRABLE TO ANY OTHER DAY. IF THE PARTICIPANT WISHES TO CONSERVE THE 30-MINUTE ALLOTTED REPAIR TIME, HE/SHE MUST DECLARE A FORFEIT BEFORE OR UPON RACING. IN THE BIG FINALS, THE TIME ALLOTTED FOR REPAIRS IS 15 MINUTES.**

**N.B. The violation of any of the rules will result in disqualification.**
